Important 2022 Tax Information

Members Plus has mailed the 2022 tax forms. Currently, tax forms are not available online. Please keep the following details in mind:

 1099-INT forms are sent out only to those members whose total interest earned for the year was \$10.00 or more. If the total interest you earned was less than \$10.00, no interest form would have been sent to you.

- Your Year-to-Date (YTD) interest income is always available on your December statement(s). A YTD summary for interest dividends earned will be listed for each interest-earning deposit account.
- 1098 forms are sent out if the Mortgage Interest Paid by Member is greater than \$600.00.
